Health Guarantee

This sales and health guarantee contract covers illness in incubation that could not be detected at the date of delivery of the canine, for a maximum of fifteen days, as well as major congenital malformations which could seriously and exclusively hinder the health of the canine over twelve months (hip dysplasia, heart murmur, etc.) This guarantee of health covers serious congenital malformations, as described previously, until the canine reaches the **age of thirty six months**. Any and all congenital defects affecting esthetic value are not covered by this guarantee. Any and all loss of the canine through accidental death, poisoning, theft, flight, disappearance or any other cause is not covered by this guarantee after canine has been delivered. Safe arrival to the United States is guaranteed by EuroHund.

During the period covered by this guarantee, if the canine is found to be suffering from an illness/disease covered by this guarantee by a Doctor of Veterinary Medicine, EuroHund must be contacted within twenty four hours of diagnosis. A plan of action will be instituted that may include temporary or permanent return of the canine to EuroHund. EuroHund reserves the right and privilege to decide if the canine will be replaced or treated by a veterinarian chosen by EuroHund.

Any buyer using this guarantee to replace the canine agrees to return the live canine to EuroHund. In the case of a fatal illness, contracted before time and date of delivery, a history of treatment and a definitive cause of death by a licensed Doctor of Veterinary Medicine must be provided.

This guarantee will provide a replacement canine only. Monetary refunds or reimbursements may be made in rare instances as a gesture of goodwill and at the sole discretion of EuroHund.

Should the buyer place this canine under the care of any other representative of the trade (breeder, friend, veterinarian, trainer, etc.) without prior written authorization from EuroHund, the buyer assumes responsibility for all risks and costs their actions entail.

This guarantee is non-transferable, if ownership of the canine changes this guarantee is void.

This guarantee is void if the canine is bred, chronically overweight, injury leads to arthritis or other malformation, does not receive annual veterinary care,

The buyer agrees to grant EuroHund full access to any and all veterinary records pertaining to this canine. By signing below you grant an irrevocable veterinary records release to EuroHund.

EuroHund will not be responsible for costs/damages incurred related to this canine, for any reason, after the date and time of delivery. Full payment must be tendered and available to EuroHund for this guarantee to be valid.

Sales Contract

EuroHund accepts \$ _____ to hold the canine, identified on page one, until: 6 weeks after arrival in U.S. .

After that date the buyer will have surrendered any and all rights to this canine and any payment made toward the purchase of said canine. EuroHund may sell or offer for adoption the above canine. If buyer does not show at the agreed time and place of delivery or full payment is not or has not been made, buyer surrenders all rights to this canine and no refunds shall be issued.

If delivery is not able to take place at the agreed upon time and place due to circumstances beyond the control of buyer or EuroHund, an alternate delivery date/place will be set no later than one week after original delivery date. This includes but is not limited to dangerous road conditions, forecasted dangerous weather conditions, mechanical breakdown, traffic delays beyond 1 hour, accident, illness and injury. Any form of payment must be available as cash to EuroHund within seven days of receipt. Acceptance of any form of payment is at the discretion of EuroHund. Any fees associated with buyer's form of payment shall be an additional charge to buyer, including returned check and other bank fees.

If at anytime I, the buyer, or my immediate family can no longer care for or choose not to continue care of this canine, I agree to offer EuroHund first right of refusal to purchase or take full and permanent custody of the canine at a price set by Buyer.

No refunds or replacements will be granted outside of the Health Guarantee, if included. No warranty is made in regards to this canine as a show, breeding, service, working, or any other performance of canine beyond a family pet. I have read the above conditions of deposit/sale.
